Dear Eberhard:

Yesterday received your letter 7/12/83. It is regrettable the state of this situation. Last week I saw at Acapulco Mgr. Carmona, he received a letter from Mgr. Gerard des Lauriers, but it is in french and has not been translated yet.

Enclosed the Bulletins in french and english being circulated by Father Barbará. Gloria and myself are shocked to know that the consecration of Christian Marie Datessen, from the schismatic sect Note Dame de Betlehehem, and 3 priests of this sect is true. How can a catholic Bishop consecrate schismatic or ordain schismatics? This terrible blow has made us think that also the consecration of Jean Laborie of L'Eglise Latine the Toulousse is true, as well as the ordinations of Arbinet, Garcia, Miguet, Meunier; according Father Barbará, bulletin in french, page 4 all these apostates are still in their sects.

The question is. The consecrations of Mgr. des Lauriers, Carmona, Zamora are valid, but if Mgr. Thuc acts like a schismatic bishop, consecrating and ordaining schismatics, then the consecrations are illicit, and they donot have the apostolic sucesion. This is what worries us. Mgr. Carmona will write you asking please, for God and His Holy Mother to make a complete investigation of this acusations from Fr. Barbará. It is necessary you find if Mgr. Thuc really consecrated Laborie, Enos, and the apostate priests. We have no other means to know the truth but trough you, Mgr. Thuc when he arrived to Mexico, had lost partially his memory, asked on these matters by Mgr. Vezelis, he say he did not remember. What a terrible situation; What worries Gloria and me is our eternal salvation, if in good faith we have made an error it is necessary to recognize it.

I regret very much the Acapulco document. It was indeed very poor. I regret the error of Mgr. Zamora, he acts like that, it is true that in Argentine the Secretary of the Israeli Organizations was a Barbará, but he should not have wrote the way he wrote.

So many years working to preserve the catholic faith, almost 20 years, so much effort, anguish, danger, and now we know that Mgr. Thuc consecrated Bishop Christian Marie Datessen whom is said to be apostate of the catholic Church, according Fr. Barbará. For a period of time, we thought Fr. Barbará was lying, he was resented since he was not consecrated, but now, if we know trough you that this last acusation is true, then, it is reasonable to think others are true also. We depend on you, please make an investigation, find out if really Laborie was consecrated as well as Enos, if the priests were ordained.

This, I tell you is the most terrible moment in my life, I Cannot sleep, thinking that trying to save the apostolic sucesion we have fallen in schism.

Please give my best regards to Dr. Hiller, good he won his lawsuit against Prof. Lauth. Please give warmth regards to your wife and children, God protect us, but we must know the truth. Your friend,
