Dear Dr. Heller:

I receive your postal-letter and I thank you it very much, as I know you are very very busy.

About my article, I shall ask Mr. Weibel for it, without any word more. About your philosophy, you don't have to promise nothing! I have wrote you that we are sure that you are catholics, and we are also sure that our enemies will do all against us. As I am - looking they will go by the way of discredit us, as we see in the - newspaper notice about Fernández Krohn. So, I think we must be very scrupulous with the candidates to be bishops. About this, I have had a terrible week, with the problem with father Lavagnini and another things I tell you in this.

1.- We didn't know the friendships of Father Lavagnini with Mr. Manuel Martínez, who has pornografic cinemas and gives him money for the temple. The another question is that this man as I told you, is living with a woman that is not his wife. He comes to live in Cuernavaca, Morelos, a three years ago, and his cinemas had make him famous and rich; then, it is impossible that people there don't know him, and this circumstance makes more notoriety the relations between Mr. Martínez and Father Lavagnini. Father Lavagnini has a few time beeing his friend, it is another Father, Pedro Toledo, who is in Santa Rosa temple who has a more contact with Mr. Martínez. Mr. Martínez is looking for something we don't know what is, but he goes to the reunions of the tradicionalists and has divided them. Father Toledo has been called to obedience but he is very independent; he never will be a candidate.

But the most important is about Father Lavagnini. He has a very good curriculum, but with this circumstance of his friendship with Mr. Martínez, beeing in the Diocesis of "bishop" Méndez Zarco, he is a candidate to the attacks that postconciliaris when he will be a bishop. I am affraid about this, because it would be terrible that e is a posibilidad to say bad things about our elections.

Father Lavagnini has accepted, -and I known this two days ago-, the ring and the bishop's crosier as a gift of Mr. Martínez! Well, then, Ing. González and another of the Directive, had been speaking with me by teleffone, and I beg to Mgr. Carmona to do this:

1.- First, to let in suspense for two months more the consacrations of Father Lavagnini.

2.- To forbide him to accepte the gifts from Mr. Martínez.

3.- To breack the friendship with Mr. Martínez and to call him to ordein his life as he says he e is a catholic.

4.- To write a document where Father Lavagnini pramis to have no more contact with Martínez, and about another friend he has that is the chef of a group of peoples "Tradicionalists" that gane money with false "aparitions" and that don't recognize the vacancy. This friendship the Father Lavagnini conserves because this friend was the first that instructed him about the New Mass a ten years ago, and put him in contact with us, it is truth, but after this the division becom

when Father Sáenz y Arriaga wrote about the Vacancy, and this group didn't accept it.

Then I called to Mgr. Carmone to tell him this things, and I had another surprise:

Mgr. Carmona thinks that it is enough with the promise written by Father Lavagnini. The two months we ask for, were to give a time for people know the decision of F. Lavagnini to break with Mr. Martínez. But Mons. Carmona says that this was to hurt the Father; I insist; I hope both two will accept. If we have known this point we had not think in Lavagnini as a candidate, because he is not a layman; he is a priest, and this questions, more if he would be a bishop, are great nocivity for him, and for our Church.

But it is not all about this problem. To do this consecrations, of Father Roberto Martínez, Benigno Bravo and Lavagnini, Mgr. Carmona didn't tell nothing about the date, that Ing. González and me known a few days ago. We had as candidates the three Fathers but have not decided about this unanimously, at it should be, after a good investigation, even they are known for us. You see, very near and we didn't know about the friendship Lavagnini-Martínez!

It was a surprise for us to know that Mgr. Carmona has all prepare for 18 of this month. And the worst is, that Ing. González called me yesterday, to tell me that Mgr. Zamora don't know the date of the consecrations, and that he didn't know that Father Lavagnini would be consecrated, and that he, Mgr. Zamora, don't accepts F. Lavagnini, as he thinks he is not able to be a bishop! Ing. González is going to call Mgr. Carmona about this, as we see that Mgr. is not doing the things in accord with Mgr. Zamora. I have not yet the curriculums of Father Roberto Martínez and Father Bravo!

Now, I want to beg you something very important to finish with disorder actions in so very delicated questions. Mgr. Carmona told me that they, and the Fathers in the United States, accepted the "Conditions" I wrote to the admission of candidates. I ask him, ¿If you accept how you didn't do the things in accord with the conditions?...

I think it is urgently that if Excelence Mgr. Thuc accepts the Conditions, and you also, please sent a copy of the Document as soon as posible, with the corrections Mgr. Thuc or you could be did, and the Document with the sign of Mgr. Thuc; this is necessary, because as I, woman and member of the Union, elaborate the conditions. the bishops and Fathers can think that a woman is imposing they laws. It is sad, but all this years Fathers of Union have been discontent because I have made many things, as the Rules for the Union, and another documents of important decisions to do things be in order. They don't like that I do "Trento" but when Father Sáenz died, I wait two months to see if one of the Fathers resucitate it, but no one of them do this, and then I offer to continue with the Bulletin. I don't do things to impose nothing, I do all thinking in the good of our Church, as the "Conditions".

In this case, for example, those that were accordings between the bishops and us, to know the Curriculums with enough time, to send them to you before the consecrations, and about Mgr. Carmona to notifie Mgr. Zamora about new candidates, all this has not been done. I think only authority of Mons. Thuc can do go in order our bishops and all the future.

The date for consecrations is 18. You will receive this perhaps the same day. I beg you for the love of our Lord, to

send the "Conditions" if they were accepted, as soon as possible, to Fathers Carmona and Zamora, Ing. González and me, please.

Thanks for all, and we hope that if Mgr. Excellence Thuc with his authority puts a "halt!" to disorders all should be by good way. It is very important. Our bishops are going very fast in the consecrations; we need time to investigate, and rules to assure that new bishops would not go to do rung things bad for our Cause.

With salutes from my mother for all you, and pray for us that are with this problems.
