

Part of letter sent
to Mgr. Des Lauriers

With great difficulty I was able to get the F.B.I. (Federal Bureau of Investigation - a national semi-secret detective agency), to agree to "search" for Mgr. Thun. If higher powers (masses) in our government and in the "Church" do not stop them, Mgr. Thun should be recovered very soon. That is a big "if" as we say in English.

There is a small problem. How to get Mgr. Thun back to you, if that is where he should be returned. I assume we can put him on an airplane and you will meet him at the airport in Paris. (If necessary I would travel with him.) The F.B.I. asked us (Father Francis & I) why you and Dr. Keller have done nothing in your countries to recover Archbishop Thun, such as contacting your government, or the American Embassy urging them to investigate the matter. I told them you had not because you believed that if Bishop Vegellis was unsuccessful in America, then how could you be successful outside of America? However, now that we know Bis. Vegellis is not interested in recovering the Archbishop, as I explained to you when we met, it would be a great help, I think, if you would indeed make every effort in your country to get some action and an accounting (explanation) as to where the Archbishop is. Without your help and the help of Dr. Keller, I work alone.

Enclosed are the 'highlights' of the information given to our F.B.I. It may be helpful to you to understand and to explain to others if necessary.

I have kept this information and the investigation of the F.B.I. a secret from everyone here in America, including even Bishop Muesy, who seems indifferent towards recovering Mgr. Thuc. Fr. Victor Vida Elmer has been told in confidence. I am sending the enclosed to Doctor Keller whom I have not met. You & he and Fr. Vida are the only ones to receive it.

Please keep in contact with me, and be ready to come here, if possible, to testify on behalf of Mgr. Thuc, (which may be necessary to prove his true intention of returning to France.)

Dear Dorothy Keller;

I have not met you but I know of you from Einsicht, plus I know the traditional priests and Bishops behind you in this country.

I have been trying to recover Mgr. Thuc and have had little success until recently, when I was able to get the authorities to initiate an investigation (10/15/84). (Pray many rosaries that it will be completed and be successful.)

Your name was submitted to the "Detectives" (F.B.I.) as an interested friend of Mgr. Thuc. I also thought that you could help establish and prove, at least by your testimony, that Mgr. Thuc came to America only to visit; and that he had every intention of returning to France.

The reason, I am very very sorry to say, why Mgr. Thuc has not been recovered up till now is because Bishop Vezellis has discouraged any investigation. He is ambitious and does not want competition, or any more bishops in the world. Therefore if Mgr. Thuc is kidnapped he will (1) not be able to consecrate another bishop and (2) Bishop Vezellis will not have to take care of ~~an~~ old man!

I know this to be true because I was a seminarian in Rochester and lived with Mgr. Thuc and Bishop Vezellis for 3 months. Also I was in New York City with Bishop Vezellis the last time anyone (traditionalist) saw the Archbishop. On that day (Feb. 6, 1984) and the next I was told no less than six (6) times how it would be better for the friary to "let Mgr. Thuc go." (He was trying to convince me it was a good idea, but inside of me, to say the best, I was extremely angry.) Therefore at the first opportunity (Feb. 10) I left the Seminary (friary).

Enclosed is the information given to our F.B.I.
Included is part of a letter sent to Mr. Des Lauriers
which will help explain what I am doing, and
applies for you also. I may need your help very soon.
I don't think it would be a good idea to make this
report public until the investigation is completed as
the captors of Mr. T. may might thereby be alerted
and hide the Archbishop in a new place.

Thank you for your help. Please ask others
to pray the rosary.
